

## SOLVED EXAMPLES

**Ex. 1** Find the coordinates of foci, the eccentricity and latus-rectum, equations of directrices for the hyperbola  $9x^2 - 16y^2 - 72x + 96y - 144 = 0$ .

**Sol.** Equation can be rewritten as  $\frac{(x-4)^2}{4^2} - \frac{(y-3)^2}{3^2} = 1$  so  $a = 4, b = 3$

$$b^2 = a^2(e^2 - 1) \text{ given } e = \frac{5}{4}$$

Foci :  $X = \pm ae, Y = 0$  gives the foci as  $(9, 3), (-1, 3)$

Centre :  $X = 0, Y = 0$  i.e.  $(4, 3)$

Directrices :  $X = \pm \frac{a}{e}$  i.e.  $x - 4 = \pm \frac{16}{5} \quad \therefore$  directrices are  $5x - 36 = 0; 5x - 4 = 0$

$$\text{Latus-rectum} = \frac{2b^2}{a} = 2 \cdot \frac{9}{4} = \frac{9}{2}$$

**Ex. 2** Find the eccentricity of the hyperbola whose latus rectum is half of its transverse axis.

**Sol.** Let the equation of hyperbola be  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$

Then transverse axis  $= 2a$  and latus-rectum  $= \frac{2b^2}{a}$

According to question  $\frac{2b^2}{a} = \frac{1}{2}(2a)$

$$\Rightarrow 2b^2 = a^2 \quad (\Rightarrow b^2 = a^2(e^2 - 1))$$

$$\Rightarrow 2a^2(e^2 - 1) = a^2 \quad \Rightarrow 2e^2 - 2 = 1$$

$$\Rightarrow e^2 = \frac{3}{2} \quad \therefore e = \sqrt{\frac{3}{2}}$$

Hence the required eccentricity is  $\sqrt{\frac{3}{2}}$ .

**Ex. 3** If  $(a \sec\theta, b \tan\theta)$  and  $(a \sec\phi, b \tan\phi)$  are the ends of a focal chord of  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$ , then  $\tan \frac{\theta}{2} \tan \frac{\phi}{2}$  equal to -

**Sol.** Equation of chord connecting the points  $(a \sec\theta, b \tan\theta)$  and  $(a \sec\phi, b \tan\phi)$  is

$$\frac{x}{a} \cos\left(\frac{\theta + \phi}{2}\right) - \frac{y}{b} \sin\left(\frac{\theta + \phi}{2}\right) = \cos\left(\frac{\theta + \phi}{2}\right) \quad \dots\dots\dots (i)$$

If it passes through  $(ae, 0)$ ; we have,  $e \cos\left(\frac{\theta + \phi}{2}\right) = \cos\left(\frac{\theta + \phi}{2}\right)$

$$\Rightarrow e = \frac{\cos\left(\frac{\theta + \phi}{2}\right)}{\cos\left(\frac{\theta - \phi}{2}\right)} = \frac{1 - \tan \frac{\theta}{2} \cdot \tan \frac{\phi}{2}}{1 + \tan \frac{\theta}{2} \cdot \tan \frac{\phi}{2}} \quad \Rightarrow \quad \tan \frac{\theta}{2} \cdot \tan \frac{\phi}{2} = \frac{1 - e}{1 + e}$$

Similarly if (i) passes through  $(-ae, 0)$ ,  $\tan \frac{\theta}{2} \cdot \tan \frac{\phi}{2} = \frac{1 + e}{1 - e}$

**Ex. 4** Prove that the straight line  $lx + my + n = 0$  touches the hyperbola  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$  if  $a^2l^2 - b^2m^2 = n^2$ .

**Sol.** The given line is  $lx + my + n = 0$  or  $y = -\frac{l}{m}x - \frac{n}{m}$

Comparing this line with  $y = Mx + c$

$$\therefore M = -\frac{l}{m} \text{ and } c = -\frac{n}{m} \quad \dots\dots(1)$$

This line (1) will touch the hyperbola  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$  if  $c^2 = a^2M^2 - b^2$

$$\Rightarrow \frac{n^2}{m^2} = \frac{a^2l^2}{m^2} - b^2$$

$$\text{or } a^2l^2 - b^2m^2 = n^2$$

**Ex. 5** A common tangent to  $9x^2 - 16y^2 = 144$  and  $x^2 + y^2 = 9$  is -

**Sol.**  $\frac{x^2}{16} - \frac{y^2}{9} = 1$ ,  $x^2 + y^2 = 9$

Equation of tangent  $y = mx + \sqrt{16m^2 - 9}$  (for hyperbola)

Equation of tangent  $y = m'x + 3\sqrt{1 + m'^2}$  (circle)

For common tangent  $m = m'$  and  $3\sqrt{1 + m'^2} = \sqrt{16m^2 - 9}$

$$\text{or } 9 + 9m^2 = 16m^2 - 9$$

$$\text{or } 7m^2 = 18 \Rightarrow m = \pm 3\sqrt{\frac{2}{7}}$$

$$\therefore \text{required equation is } y = \pm 3\sqrt{\frac{2}{7}}x \pm 3\sqrt{1 + \frac{18}{7}}$$

$$\text{or } y = \pm 3\sqrt{\frac{2}{7}}x \pm \frac{15}{\sqrt{7}}$$

**Ex. 6** Find the equation and the length of the common tangents to hyperbola  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$  and

$$\frac{y^2}{a^2} - \frac{x^2}{b^2} = 1.$$

**Sol.** Tangent at  $(a \sec \phi, b \tan \phi)$  on the 1st hyperbola is

$$\frac{x}{a} \sec \phi - \frac{y}{b} \tan \phi = 1 \quad \dots\dots(i)$$

Similarly tangent at any point  $(b \tan \theta, a \sec \theta)$  on 2nd hyperbola is

$$\frac{y}{a} \sec \theta - \frac{x}{b} \tan \theta = 1 \quad \dots\dots(ii)$$

If (1) and (2) are common tangents then they should be identical. Comparing the co-efficients of  $x$  and  $y$

$$\Rightarrow \frac{\sec \theta}{a} = -\frac{\tan \phi}{b} \quad \dots\dots(iii)$$

and  $-\frac{\tan \theta}{b} = \frac{\sec \phi}{a}$

or  $\sec \theta = -\frac{a}{b} \tan \phi$  .....(iv)

→  $\sec^2 \theta - \tan^2 \theta = 1$

⇒  $\frac{a^2}{b^2} \tan^2 \phi - \frac{b^2}{a^2} \sec^2 \phi = 1$  {from (iii) and (iv)}

or  $\frac{a^2}{b^2} \tan^2 \phi - \frac{b^2}{a^2} (1 + \tan^2 \phi) = 1$  or  $\left( \frac{a^2}{b^2} - \frac{b^2}{a^2} \right) \tan^2 \phi = 1 + \frac{b^2}{a^2}$

$$\tan^2 \phi = \frac{b^2}{a^2 - b^2}$$

and  $\sec^2 \phi = 1 + \tan^2 \phi = \frac{a^2}{a^2 - b^2}$

Hence the point of contact are

$$\left\{ \pm \frac{a^2}{\sqrt{(a^2 - b^2)}}, \pm \frac{b^2}{\sqrt{(a^2 - b^2)}} \right\} \text{ and } \left\{ \pm \frac{b^2}{\sqrt{(a^2 - b^2)}}, \pm \frac{a^2}{\sqrt{(a^2 - b^2)}} \right\} \text{ {from (3) and (4)}}$$

Length of common tangent i.e., the distance between the above points is  $\sqrt{2} \frac{(a^2 + b^2)}{\sqrt{(a^2 - b^2)}}$  and

equation of common tangent on putting the values of  $\sec \phi$  and  $\tan \phi$  in (1) is

$$\pm \frac{x}{\sqrt{(a^2 - b^2)}} \pm \frac{y}{\sqrt{(a^2 - b^2)}} = 1 \quad \text{or} \quad x \pm y = \pm \sqrt{(a^2 - b^2)}$$

**Ex. 7** Line  $x \cos \alpha + y \sin \alpha = p$  is a normal to the hyperbola  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$ , if -

(A)  $a^2 \sec^2 \alpha - b^2 \operatorname{cosec}^2 \alpha = \frac{(a^2 + b^2)^2}{p^2}$

(C)  $a^2 \sec^2 \alpha + b^2 \operatorname{cosec}^2 \alpha = \frac{(a^2 + b^2)^2}{p^2}$

(C)  $a^2 \cos^2 \alpha - b^2 \sin^2 \alpha = \frac{(a^2 + b^2)^2}{p^2}$

(D)  $a^2 \cos^2 \alpha + b^2 \sin^2 \alpha = \frac{(a^2 + b^2)^2}{p^2}$

**Sol.** Equation of a normal to the hyperbola is  $ax \cos \theta + by \cot \theta = a^2 + b^2$

comparing it with the given line equation

$$\frac{a \cos \theta}{\cos \alpha} = \frac{b \cot \theta}{\sin \alpha} = \frac{a^2 + b^2}{p} \Rightarrow \sec \theta = \frac{ap}{\cos \alpha (a^2 + b^2)}, \tan \theta = \frac{bp}{\sin \alpha (a^2 + b^2)}$$

Eliminating  $\theta$ , we get

$$\frac{a^2 p^2}{\cos^2 \alpha (a^2 + b^2)^2} - \frac{b^2 p^2}{\sin^2 \alpha (a^2 + b^2)^2} = 1 \Rightarrow a^2 \sec^2 \alpha - b^2 \operatorname{cosec}^2 \alpha = \frac{(a^2 + b^2)^2}{p^2}$$

**Ex. 8** Find the locus of point of intersection of perpendicular tangents to the hyperbola  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$

**Sol.** Let P(h, k) be the point of intersection of two perpendicular tangents. Equation of pair of tangents is  $SS_1 = T^2$

$$\Rightarrow \left( \frac{x^2}{a^2} - \frac{y^2}{b^2} - 1 \right) \left( \frac{h^2}{a^2} - \frac{k^2}{b^2} - 1 \right) = \left( \frac{hx}{a^2} - \frac{ky}{b^2} - 1 \right)^2$$

$$\Rightarrow \frac{x^2}{a^2} \left( -\frac{k^2}{b^2} - 1 \right) - \frac{y^2}{b^2} \left( \frac{h^2}{a^2} - 1 \right) + \dots = 0 \quad \dots (i)$$

Since equation (i) represents two perpendicular lines

$$\therefore \frac{1}{a^2} \left( -\frac{k^2}{b^2} - 1 \right) - \frac{1}{b^2} \left( \frac{h^2}{a^2} - 1 \right) = 0$$

$$\Rightarrow -k^2 - b^2 - h^2 + a^2 = 0 \quad \Rightarrow \text{locus is } x^2 + y^2 = a^2 - b^2$$

**Ex. 9** Find the hyperbola whose asymptotes are  $2x - y = 3$  and  $3x + y - 7 = 0$  and which passes through the point (1, 1).

**Sol.** The equation of the hyperbola differs from the equation of the asymptotes by a constant

$$\Rightarrow \text{The equation of the hyperbola with asymptotes } 3x + y - 7 = 0 \text{ and } 2x - y = 3 \text{ is}$$

$$(3x + y - 7)(2x - y - 3) + k = 0$$

It passes through (1, 1)

$$\Rightarrow k = -6.$$

Hence the equation of the hyperbola is  $(2x - y - 3)(3x + y - 7) = 6$ .

**Ex. 10** Find the condition on 'a' and 'b' for which two distinct chords of the hyperbola  $\frac{x^2}{2a^2} - \frac{y^2}{2b^2} = 1$  passing through (a, b) are bisected by the line  $x + y = b$ .

**Sol.** Let the line  $x + y = b$  bisect the chord at P( $\alpha$ ,  $b - \alpha$ )

$\therefore$  equation of chord whose mid-point is P( $\alpha$ ,  $b - \alpha$ )

$$\frac{x\alpha}{2a^2} - \frac{y(b-\alpha)}{2b^2} = \frac{\alpha^2}{2a^2} - \frac{(b-\alpha)^2}{2b^2}$$

Since it passes through (a, b)

$$\therefore \frac{\alpha}{2a} - \frac{(b-\alpha)}{2b} = \frac{\alpha^2}{2a^2} - \frac{(b-\alpha)^2}{2b^2}$$

$$\alpha^2 \left( \frac{1}{a^2} - \frac{1}{b^2} \right) + \alpha \left( \frac{1}{b} - \frac{1}{a} \right) = 0$$

$$\alpha = 0, \quad \alpha = \frac{1}{\frac{1}{a} - \frac{1}{b}} \quad \therefore a \neq \pm b$$

**Ex. 11** Chords of the circle  $x^2 + y^2 = a^2$  touch the hyperbola  $x^2/a^2 - y^2/b^2 = 1$ . Prove that locus of their middle point is the curve  $(x^2 + y^2)^2 = a^2x^2 - b^2y^2$ .

**Sol.** Let  $(h, k)$  be the mid-point of the chord of the circle  $x^2 + y^2 = a^2$ ,

so that its equation by  $T = S_1$  is  $hx + ky = h^2 + k^2$

or  $y = -\frac{h}{k}x + \frac{h^2 + k^2}{k}$  i.e. of the form  $y = mx + c$

It will touch the hyperbola if  $c^2 = a^2m^2 - b^2$

$$\therefore \left(\frac{h^2 + k^2}{k}\right)^2 = a^2 \left(-\frac{h}{k}\right)^2 - b^2 \quad \text{or} \quad (h^2 + k^2)^2 = a^2h^2 - b^2k^2$$

Generalising, the locus of mid-point  $(h, k)$  is  $(x^2 + y^2)^2 = a^2x^2 - b^2y^2$

**Ex. 12** Find the locus of the mid point of the chords of the hyperbola  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$  which subtend a right angle at the origin.

**Sol.** let  $(h, k)$  be the mid-point of the chord of the hyperbola. Then its equation is

$$\frac{hx}{a^2} - \frac{ky}{b^2} - 1 = \frac{h^2}{a^2} - \frac{k^2}{b^2} - 1 \quad \text{or} \quad \frac{hx}{a^2} - \frac{ky}{b^2} = \frac{h^2}{a^2} - \frac{k^2}{b^2} \quad \dots\dots(1)$$

The equation of the lines joining the origin to the points of intersection of the hyperbola and the chord (1) is obtained by making homogeneous hyperbola with the help of (1)

$$\therefore \frac{x^2}{a^2} - \frac{y^2}{b^2} = \frac{\left(\frac{hx}{a^2} - \frac{ky}{b^2}\right)^2}{\left(\frac{h^2}{a^2} - \frac{k^2}{b^2}\right)^2}$$

$$\Rightarrow \frac{1}{a^2} \left(\frac{h^2}{a^2} - \frac{k^2}{b^2}\right)^2 x^2 - \frac{1}{b^2} \left(\frac{h^2}{a^2} - \frac{k^2}{b^2}\right)^2 y^2 = \frac{h^2}{a^4} x^2 + \frac{k^2}{b^4} y^2 - \frac{2hk}{a^2b^2} xy \quad \dots\dots(2)$$

The lines represented by (2) will be at right angle if coefficient of  $x^2$  + coefficient of  $y^2 = 0$

$$\Rightarrow \frac{1}{a^2} \left(\frac{h^2}{a^2} - \frac{k^2}{b^2}\right)^2 - \frac{h^2}{a^4} - \frac{1}{b^2} \left(\frac{h^2}{a^2} - \frac{k^2}{b^2}\right)^2 - \frac{k^2}{b^4} = 0$$

$$\Rightarrow \left(\frac{h^2}{a^2} - \frac{k^2}{b^2}\right)^2 \left(\frac{1}{a^2} - \frac{1}{b^2}\right) = \frac{h^2}{a^4} + \frac{k^2}{b^4}$$

hence, the locus of  $(h, k)$  is  $\left(\frac{x^2}{a^2} - \frac{y^2}{b^2}\right)^2 \left(\frac{1}{a^2} - \frac{1}{b^2}\right) = \frac{x^2}{a^4} + \frac{y^2}{b^4}$

**Ex. 13** C is the centre of the hyperbola  $\frac{x^2}{a^2} - \frac{y^2}{b^2} = 1$ . The tangent at any point P on this hyperbola meets the straight lines  $bx - ay = 0$  and  $bx + ay = 0$  in the points Q and R respectively. Show that  $CQ \cdot CR = a^2 + b^2$ .

**Sol.** P is  $(a \sec \theta, b \tan \theta)$

$$\text{Tangent at P is } \frac{x \sec \theta}{a} - \frac{y \tan \theta}{b} = 1$$

$$\text{It meets } bx - ay = 0 \text{ i.e. } \frac{x}{a} = \frac{y}{b} \text{ in Q}$$

$$\therefore \text{ Q is } \left( \frac{a}{\sec \theta - \tan \theta}, \frac{b}{\sec \theta - \tan \theta} \right)$$

$$\text{It meets } bx + ay = 0 \text{ i.e. } \frac{x}{a} = -\frac{y}{b} \text{ in R.}$$

$$\therefore \text{ R is } \left( \frac{a}{\sec \theta + \tan \theta}, \frac{-b}{\sec \theta + \tan \theta} \right)$$

$$\therefore CQ \cdot CR = \frac{\sqrt{(a^2 + b^2)}}{\sec \theta - \tan \theta} \cdot \frac{\sqrt{(a^2 + b^2)}}{\sec \theta + \tan \theta} = a^2 + b^2 \quad (\rightarrow \sec^2 \theta - \tan^2 \theta = 1)$$

**Ex. 14** The asymptotes of a hyperbola having centre at the point (1, 2) are parallel to the lines  $2x + 3y = 0$  and  $3x + 2y = 0$ . If the hyperbola passes through the point (5, 3), show that its equation is  $(2x + 3y - 8)(3x + 2y - 7) = 154$

**Sol.** Let the asymptotes be  $2x + 3y + \lambda = 0$  and  $3x + 2y + \mu = 0$ . Since asymptotes passes through (1, 2), then  $\lambda = -8$  and  $\mu = -7$

$$\text{Thus the equation of asymptotes are } 2x + 3y - 8 = 0 \text{ and } 3x + 2y - 7 = 0$$

Let the equation of hyperbola be

$$(2x + 3y - 8)(3x + 2y - 7) + v = 0 \quad \dots\dots(i)$$

It passes through (5, 3), then

$$(10 + 9 - 8)(15 + 6 - 7) + v = 0$$

$$\Rightarrow 11 \times 14 + v = 0$$

$$\therefore v = -154$$

putting the value of v in (i) we obtain

$$(2x + 3y - 8)(3x + 2y - 7) - 154 = 0$$

which is the equation of required hyperbola.

**Ex. 15** A circle of variable radius cuts the rectangular hyperbola  $x^2 - y^2 = 9a^2$  in points P, Q, R and S. Determine the equation of the locus of the centroid of triangle PQR.

**Sol.** Let the circle be  $(x - h)^2 + (y - k)^2 = r^2$  where r is variable. Its intersection with  $x^2 - y^2 = 9a^2$  is obtained by putting  $y^2 = x^2 - 9a^2$ .

$$x^2 + x^2 - 9a^2 - 2hx + h^2 + k^2 - r^2 = 2k\sqrt{(x^2 - 9a^2)}$$

or  $[2x^2 - 2hx + (h^2 + k^2 - r^2 - 9a^2)]^2 = 4k^2(x^2 - 9a^2)$

or  $4x^4 - 8hx^3 + \dots = 0$

$\therefore$  Above gives the abscissas of the four points of intersection.

$\therefore \Sigma x_1 = \frac{8h}{4} = 2h$

$$x_1 + x_2 + x_3 + x_4 = 2h$$

Similarly  $y_1 + y_2 + y_3 + y_4 = 2k$ .

Now if  $(\alpha, \beta)$  be the centroid of  $\Delta PQR$ , then  $3\alpha = x_1 + x_2 + x_3$ ,  $3\beta = y_1 + y_2 + y_3$

$\therefore x_4 = 2h - 3\alpha$ ,  $y_4 = 2k - 3\beta$

But  $(x_4, y_4)$  lies on  $x^2 - y^2 = 9a^2$

$\therefore (2h - 3\alpha)^2 + (2k - 3\beta)^2 = 9a^2$

Hence the locus of centroid  $(\alpha, \beta)$  is  $(2h - 3x)^2 + (2k - 3y)^2 = 9a^2$

or  $\left(x - \frac{2h}{3}\right)^2 + \left(y - \frac{2k}{3}\right)^2 = a^2$

**Ex. 16** A, B, C are three points on the rectangular hyperbola  $xy = c^2$ , find

(i) The area of the triangle ABC

(ii) The area of the triangle formed by the tangents at A, B and C.

**Sol.** Let co-ordinates of A, B and C on the hyperbola  $xy = c^2$  are  $\left(ct_1, \frac{c}{t_1}\right)$ ,  $\left(ct_2, \frac{c}{t_2}\right)$  and  $\left(ct_3, \frac{c}{t_3}\right)$  respectively.

(i)  $\therefore$  Area of triangle ABC  $= \frac{1}{2} \left[ \begin{vmatrix} ct_1 & \frac{c}{t_1} \\ ct_2 & \frac{c}{t_2} \\ ct_3 & \frac{c}{t_3} \end{vmatrix} + \begin{vmatrix} ct_2 & \frac{c}{t_2} \\ ct_3 & \frac{c}{t_3} \\ ct_1 & \frac{c}{t_1} \end{vmatrix} + \begin{vmatrix} ct_3 & \frac{c}{t_3} \\ ct_1 & \frac{c}{t_1} \\ ct_2 & \frac{c}{t_2} \end{vmatrix} \right]$

$$= \frac{c^2}{2} \left| \frac{t_1}{t_2} - \frac{t_2}{t_1} + \frac{t_2}{t_3} - \frac{t_3}{t_2} + \frac{t_3}{t_1} - \frac{t_1}{t_3} \right|$$

$$= \frac{c^2}{2t_1t_2t_3} |t_1^2t_3 - t_2^2t_3 + t_1t_2^2 - t_3^2t_1 + t_2t_3^2 - t_1^2t_2|$$

$$= \frac{c^2}{2t_1t_2t_3} |(t_1 - t_2)(t_2 - t_3)(t_3 - t_1)|$$

(ii) Equations of tangents at A, B, C are

$$x + yt_1^2 - 2ct_1 = 0$$

$$x + yt_2^2 - 2ct_2 = 0$$

and

$$x + yt_3^2 - 2ct_3 = 0$$

$$\therefore \text{ Required Area} = \frac{1}{2|C_1 C_2 C_3|} \begin{vmatrix} 1 & t_1^2 & -2ct_1 \\ 1 & t_2^2 & -2ct_2 \\ 1 & t_3^2 & -2ct_3 \end{vmatrix}^2 \quad \dots\dots\dots (1)$$

$$\text{where } C_1 = \begin{vmatrix} 1 & t_2^2 \\ 1 & t_3^2 \end{vmatrix}, C_2 = - \begin{vmatrix} 1 & t_1^2 \\ 1 & t_3^2 \end{vmatrix} \text{ and } C_3 = \begin{vmatrix} 1 & t_1^2 \\ 1 & t_2^2 \end{vmatrix}$$

$$\therefore C_1 = t_3^2 - t_2^2, C_2 = t_1^2 - t_3^2 \text{ and } C_3 = t_2^2 - t_1^2$$

$$\begin{aligned} \text{From (1)} &= \frac{1}{2[(t_3^2 - t_2^2)(t_1^2 - t_3^2)(t_2^2 - t_1^2)]} 4c^2 \cdot (t_1 - t_2)^2 (t_2 - t_3)^2 (t_3 - t_1)^2 \\ &= 2c^2 \left| \frac{(t_1 - t_2)(t_2 - t_3)(t_3 - t_1)}{(t_1 + t_2)(t_2 + t_3)(t_3 + t_1)} \right| \end{aligned}$$

$$\therefore \text{ Required area is, } 2c^2 \left| \frac{(t_1 - t_2)(t_2 - t_3)(t_3 - t_1)}{(t_1 + t_2)(t_2 + t_3)(t_3 + t_1)} \right|$$

**Ex. 17** If a circle cuts a rectangular hyperbola  $xy = c^2$  in A, B, C, D and the parameters of these four points be  $t_1, t_2, t_3$  and  $t_4$  respectively, then prove that :

(a)  $t_1 t_2 t_3 t_4 = 1$

(b) The centre of mean position of the four points bisects the distance between the centres of the two curves.

**Sol.** (a) Let the equation of the hyperbola referred to rectangular asymptotes as axes be  $xy = c^2$  or its parametric equation be

$$x = ct, y = c/t \quad \dots\dots\dots (i)$$

and that of the circle be

$$x^2 + y^2 + 2gx + 2fy + k = 0 \quad \dots\dots\dots (ii)$$

Solving (i) and (ii), we get

$$c^2 t^2 + \frac{c^2}{t^2} + 2gct + 2f \frac{c}{t} + k = 0$$

$$\text{or } c^2 t^4 + 2gct^3 + kt^2 + 2fct + c^2 = 0 \quad \dots\dots\dots (iii)$$

Above equation being of fourth degree in  $t$  gives us the four parameters  $t_1, t_2, t_3, t_4$  of the points of intersection.

$$\therefore t_1 + t_2 + t_3 + t_4 = -\frac{2gc}{c^2} = -\frac{2g}{c} \quad \dots\dots\dots (iv)$$

$$\begin{aligned} t_1 t_2 t_3 + t_1 t_2 t_4 + t_3 t_4 t_1 + t_3 t_4 t_2 \\ = -\frac{2fc}{c^2} = -\frac{2f}{c} \quad \dots\dots\dots (v) \end{aligned}$$

$$t_1 t_2 t_3 t_4 = \frac{c^2}{c^2} = 1 \text{ . It proves (a)} \quad \dots\dots\dots (vi)$$

Dividing (v) by (vi), we get

$$\frac{1}{t_1} + \frac{1}{t_2} + \frac{1}{t_3} + \frac{1}{t_4} = -\frac{2f}{c} \quad \text{..... (vii)}$$

(b) The centre of mean position of the four points of intersection is

$$\left[ \frac{c}{4}(t_1 + t_2 + t_3 + t_4), \frac{c}{4} \left( \frac{1}{t_1} + \frac{1}{t_2} + \frac{1}{t_3} + \frac{1}{t_4} \right) \right] = \left[ \frac{c}{4} \left( -\frac{2g}{c} \right), \frac{c}{4} \left( -\frac{2f}{c} \right) \right], \text{ by (iv) and (vii)}$$

$$= (-g/2, -f/2)$$

Above is clearly the mid-point of (0, 0) and (-g, -f) i.e. the join of the centres of the two curves.

**Ex. 18** Prove that the perpendicular focal chords of a rectangular hyperbola are equal.

**Sol.** Let rectangular hyperbola is  $x^2 - y^2 = a^2$

Let equations of PQ and DE are

$$y = mx + c \quad \text{.....(i)}$$

$$\text{and } y = m_1x + c_1 \quad \text{.....(ii)}$$

respectively.

Be any two focal chords of any rectangular hyperbola  $x^2 - y^2 = a^2$  through its focus. We have to prove  $PQ = DE$ . Since  $PQ \perp DE$ .

$$\therefore mm_1 = -1 \quad \text{.....(iii)}$$

Also PQ passes through S ( $a\sqrt{2}, 0$ ) then from (1),

$$0 = ma\sqrt{2} + c$$

$$\text{or } c^2 = 2a^2m^2 \quad \text{.....(iv)}$$

Let  $(x_1, y_1)$  and  $(x_2, y_2)$  be the co-ordinates of P and Q then

$$(PQ)^2 = (x_1 - x_2)^2 + (y_1 - y_2)^2 \quad \text{.....(v)}$$

Since  $(x_1, y_1)$  and  $(x_2, y_2)$  lie on (i)

$$\therefore y_1 = mx_1 + c \text{ and } y_2 = mx_2 + c$$

$$\therefore (y_1 - y_2) = m(x_1 - x_2) \quad \text{.....(vi)}$$

From (v) and (vi)

$$(PQ)^2 = (x_1 - x_2)^2 (1 + m^2) \quad \text{.....(vii)}$$

Now solving  $y = mx + c$  and  $x^2 - y^2 = a^2$  then  $x^2 - (mx + c)^2 = a^2$

$$\text{or } (m^2 - 1)x^2 + 2mcx + (a^2 + c^2) = 0$$

$$\therefore x_1 + x_2 = -\frac{2mc}{m^2 - 1}$$

$$\begin{aligned}
 \text{and } x_1 x_2 &= \frac{a^2 + c^2}{m^2 - 1} \\
 \Rightarrow (x_1 - x_2)^2 &= (x_1 + x_2)^2 - 4x_1 x_2 \\
 &= \frac{4m^2 c^2}{(m^2 - 1)^2} - \frac{4(a^2 + c^2)}{(m^2 - 1)} \\
 &= \frac{4\{a^2 + c^2 - a^2 m^2\}}{(m^2 - 1)^2} \\
 &= \frac{4a^2(m^2 + 1)}{(m^2 - 1)^2} \quad \{\rightarrow c^2 = 2a^2 m^2\}
 \end{aligned}$$

From (vii),  $(PQ)^2 = 4a^2 \left( \frac{m^2 + 1}{m^2 - 1} \right)^2$

Similarly,  $(DE)^2 = 4a^2 \left( \frac{m_1^2 + 1}{m_1^2 - 1} \right)^2$

$$\begin{aligned}
 &= 4a^2 \left( \frac{\left( -\frac{1}{m} \right)^2 + 1}{\left( -\frac{1}{m} \right)^2 - 1} \right)^2 = 4a^2 \left( \frac{m^2 + 1}{m^2 - 1} \right)^2 = (PQ)^2 \quad (\rightarrow mm_1 = -1)
 \end{aligned}$$

Thus  $(PQ)^2 = (DE)^2 \Rightarrow PQ = DE$ .

Hence perpendicular focal chords of a rectangular hyperbola are equal.

**Ex. 19** A ray originating from the point (5, 0) is incident on the hyperbola  $9x^2 - 16y^2 = 144$  at the point P with abscissa 8. Find the equation of the reflected ray after first reflection and point P lying in first quadrant.

**Sol.** Given hyperbola is  $9x^2 - 16y^2 = 144$ . This equation can be

rewritten as  $\frac{x^2}{16} - \frac{y^2}{9} = 1$  .....(i)

Since x co-ordinate of P is 8. Let y co-ordinate of P is  $\alpha$ .

$\rightarrow (8, \alpha)$  lies on (i)

$$\therefore \frac{64}{16} - \frac{\alpha^2}{9} = 1$$

$$\Rightarrow \alpha^2 = 27$$

$$\Rightarrow \alpha = 3\sqrt{3} \quad (\rightarrow P \text{ lies in first quadrant})$$



Hence co-ordinate of point P is  $(8, 3\sqrt{3})$ .

$\rightarrow$  Equation of reflected ray passes through P  $(8, 3\sqrt{3})$  and  $S'(-5, 0)$

$$\therefore \text{Its equation is } y - 3\sqrt{3} = \frac{0 - 3\sqrt{3}}{-5 - 8} (x - 8)$$

$$\text{or } 13y - 39\sqrt{3} = 3\sqrt{3}x - 24\sqrt{3}$$

$$\text{or } 3\sqrt{3}x - 13y + 15\sqrt{3} = 0.$$


